

## **DATA PROTECTION POLICY:**

### **Purpose and legal basis**

[www.phostit.it](http://www.phostit.it) processes personal data in relation to the services offered exclusively for the purposes that you read in the document "Terms and Conditions of Use".

The processing also concerns the personal data necessary to enable the user who requests it to use the online sales services.

Any refusal to provide personal data by the person concerned makes it impossible for him/her to use the services for which an identified registration is required.

The consent may be revoked at any time, with consequent deactivation of the service, by accessing the reserved area of your profile or by writing an email to [info@phostit.it](mailto:info@phostit.it).

### **Browsing data**

The computer systems and software procedures used to operate this website acquire certain personal data.

These data are not collected to associate them with identified subjects but may be processed for statistical purposes (most visited pages, number of visitors per hour or day, geographical areas of origin, etc.) and to check the proper functioning of services.

However, this data could allow users to be identified if necessary to ascertain responsibility in case of hypothetical computer crimes against the website.

### **Data provided by the user**

The optional, explicit and voluntary sending of electronic mail to the addresses indicated in the different channels of access to the site involves the subsequent acquisition of the sender's address, necessary to respond to requests, as well as any other personal data written.

The data acquired will be processed exclusively to respond to requests from users who, where necessary, may be contacted via email, telephone or other communication systems.

### **Processing and storage of data**

The data are processed using paper, computer and telematic instruments in compliance with the regulations and with instruments suitable to guarantee their security and confidentiality.

The personal data provided are processed exclusively for purposes related to the achievement of the requested purposes. In compliance with the principles of lawfulness, purpose limitation and data minimization, pursuant to art. 5 of EU Regulation 2016/679, subject to the free and explicit consent of the user expressed at the time of registration, personal data are kept for the period of time necessary to achieve the purposes for which they are collected.

In case the user chooses a service, managed in whole or in part by another partner, his data will be communicated, as requested and/or expected, to the individual partners. The partners are responsible for the processing connected to the provision of the services under their competence.

### **Addressees or categories of addressees**

They have the right to lodge a complaint with the Guarantor for the protection of personal data, as a supervisory authority and the right to appeal to the judicial authority.
